

#### MEMBERSHIP OF THE UNEMPLOYMENT FUND OF SERVICE UNION UNITED

Membership in the Unemployment Fund of Service Union United is open to all paid employees under the age of 68 years who are employed at the time of joining the Fund. If you are working part-time, the joining date must be a working day. You cannot become a member of the Unemployment Fund when you are unemployed or laid off.

You can only be a member of one unemployment fund at the same time. If you join the Unemployment Fund of Service Union United within one month after resigning from another fund, your employment and membership periods are transferred to us directly from the previous fund. This requires that your membership fees to the previous fund have been paid in full up to the date of your resignation.

You cannot join the Unemployment Fund of Service Union United if you are self-employed. You can be considered to be self-employed if you are employed in your own company or the company of a family member or a person living in the same household of which you own a sufficiently large share. If you work in a company owned by a family member without having a personal ownership of the company, you can apply for unemployment fund membership as a paid employee.

#### You can apply for membership using the attached form

You can apply for membership of the Unemployment Fund of Service Union United with a written application. The membership starts from the date from which your membership fees are paid. However, membership can begin at the earliest from the date on which the Unemployment Fund receives your membership application.

In 2024, the annual membership fee for the Unemployment Fund of Service Union United is 84 euros (7  $\in$  / month). The membership fee must be paid for the whole year at once as per the invoice's due date. If you join the Unemployment Fund in the middle of a month, the membership fee for that month must be paid in full.

As a member of the Unemployment Fund you are entitled to earnings-related unemployment allowance on the basis of the Unemployment Security Act as well as other statutory benefits paid by the Fund.

The Unemployment Fund will send you a written decision on your acceptance as a member as well as more detailed information about member rights and obligations.
