

MEMBERSHIP OF THE UNEMPLOYMENT FUND OF SERVICE UNION UNITED

Membership in the Unemployment Fund of Service Union United is open to all paid employees under the age of 68 who are employed at the time of joining. If you work part-time, your membership must begin on a working day. You cannot join an unemployment fund if you are unemployed or laid off.

You may only be a member of one unemployment fund at a time. If you join the Unemployment Fund of Service Union United within one month of leaving another fund, your employment and membership periods will be transferred directly from your previous fund. This requires that your membership fees have been paid in full up to the date your previous membership ended.

You cannot join the Unemployment Fund of Service Union United if you are self-employed. You are considered self-employed if you work in a company that you own, or that is owned by a family member or someone in your household, and you hold a significant ownership stake in that company. However, if you work in a company owned by a family member without any a personal ownership, you may apply for membership as a paid employee.

Apply for membership using the attached form

You can apply for membership in the Unemployment Fund of Service Union United by submitting a written application. Your membership will start from the date on which your membership fees are paid. However, membership cannot begin before the date on which the Fund receives your application.

In 2026, the annual membership fee for the Unemployment Fund of Service Union United is 84 euros (7 € / month). The fee must be paid for the entire year by the due date indicated on the invoice. If you join the Fund partway through a month, the membership fee for that month is charged in full.

As a member of the Fund you are entitled to earnings-related unemployment allowance under the Unemployment Security Act, as well as other statutory benefits paid by the Fund.

The Fund will send notify you of your membership, along with more detailed information on your rights and obligations as a member.
